Dear Members,

Greetings of the Season to you and your family!!!

1. FIP has always endeavoured to look after the welfare of Pilots and their families. We have been very vocal about the cases related to safety standards in aviation/ FDTL.

2. The biggest advantage of enrolling in the FIP's Loss of licence Policy is the hassle-free claim settlement process. In the last 17 years we have paid our members **311 Crores**, out of which we have settled the following claims: -

- a) 1946 TMU Claims
- b) 108 PMU Claim and
- c) 26 unfortunate Personal Accident claims have been settled.
- d) We can proudly state that not a single claim has been rejected and all claims have been settled hassle free and without any delay.

3. As you are aware in C.Y. 2025, **M/s. Howden Insurance Brokers India Pvt. Ltd as the Broker and M/s. The New India Assurance Company Ltd.** as the Insurer have been awarded the Loss of Licence Policy 2026. The previous insurance company **GO Digit Ltd**, with the number of increase of claims going upto 175 claim as of 22.12.2025 Go Digit was asking for an increase of 15% Increase in the premium over last year. The Managing Committee was not ready to accept this steep increase and requested the Brokers M/s. Howden to go into the market and search for a new insurer. Howden after doing a lot of ground work was finally able to tie up with New India Assurance company with a nominal increase of 2.5% over last year's premium and with additional sum insured brackets.

4. We would like to inform members that this year we have increased the Sum Insured for the following age groups over previous year: -

- a) Age Group 56 – 58 - Sun Insured increase for 1,20,00,000 to 1,50,00,000/-
- b) Age Group 59 – 60 - Sun Insured increase for 80,00,000 to 1,10,00,000/-
- c) Age Group 61 – 62 - Sun Insured increase for 70,00,000 to 1,00,00,000/-
- d) Age Group 63 – 65 - Sun Insured increase for 60,00,000 to 80,00,000/-

5. We are glad to inform you that this year, Indian Pilots (Passport Holders) holding a valid flying license by DGCA/Foreign country license and valid medical certificate/assessment by the competent authority to exercise privileges of the same license, and who are presently employed in flying duties in India or abroad, can enrol in the subject policy as per the terms and conditions prevailing in the Loss of Licence Policy.

6. Request all members to enrol for Loss of Licence 2026 at the earliest. We have streamlined the enrollment process to make it easier for you to sign up online and enjoy the benefits.

8. The integration process will be completed shortly and the link for payment will be available on the F.I.P. website. The enrollment window shall be open from **26th December 2025 till 15th January 2026**. The details shall be intimated to members via Email / WhatsApp and details will also be updated on our FIP Website homepage.

9. A very important details for members who are “**Currently Medically unfit**”, these members do not require to renew the current years policy until they are declared medically fit. The previous years policy will continue for them.

10. Those members already in the policy will be given continuity cover for 15 days from the date of start of enrollment. (i.e. upto 15th January 2026)
