


MEMORANDUM OF ASSOCIATION
OF
FEDERATION OF INDIAN PILOTS

1. The name of the Federation will be "**FEDERATION OF INDIAN PILOTS**".
2. The Registered office of the Federation will situate in the City of Mumbai, at Operation Building, Old Airport, Santa Cruz (East), Bombay -400 029.
3. The objects for which the Federation is established are :-
 - i. To carry out all activities to develop the profession of and the field of aviation and to encourage citizens to join this profession and field and to provide all facilities and assistance to individuals so joining.
 - ii. To undertake research and publication of literature on problems and subjects relating to the activities and/or interest of the Federation and its members.
 - iii. To improve professional knowledge amongst pilots in particular and all aviators in general.
 - iv. To interact with government and other professional bodies, national and international, for assimilation and dissemination of professional information.
- V. To arrange symposiums, lectures, and meetings for enhancing useful knowledge on latest developments in the field of aviation.



- vi. To help young and budding aviators, in all possible manner, to achieve high standards of competence in the aviation field.
- vii. To advise, interact and assist any Government of India agency to improve the overall safety standards of aviation in the country.
- viii. To conduct and encourage research in the fields of Flight Safety and Aviation Medicine, specially pertinent to Indian conditions. Generally
- ix. And to do all acts and undertake all activities necessary conducive incidental or ancillary to attain the above mentioned objects and more particularly
- (a) to raise the standards of professional competence and maintain them at a high level by instituting and developing schemes of instructions in and by stimulating discussion on various aspects of the aviation through conferences,
 - (b) debates, seminars, demonstrations study circle meetings, residential study course, etc.
 - (c) To institute and establish scholarships, grants, prizes and rewards and to encourage and promote the study and research in the subject of interest to the profession of the Pilots, Aviators, Flyers, Hang gliders, etc
- (c) To establish library and reading rooms for the use of the members of the Federation and to arrange for circulation and publication of books, journals, bulletins, pamphlets, etc.
- (d) To co-operate and maintain for the benefit of the members of the Federation constructive liaison with all organizations interested in the profession of Pilots, Aviators, etc. such as Air India Pilot Welfare Society, Indian Pilots Guild, International Federation of Airline Pilots Association, etc.

- (e) To submit views or make representation before Government or other authorities, Committees, Commissions or other bodies on any subject affecting the interest of the members or on any matter covered under the objects of the Federation and to promote or assist the promotion of any legislation or regulation which may appear to be in the interest of the members of the Federation and to suggest improvements in the law affecting the Profession.
- (f) To disseminate useful knowledge regarding the functions, duties and responsibilities of Pilots, Aviators, Flyers, Hang gliders etc.
- (g) To arrange lectures, conferences, social functions and such other opportunities for meeting with a view to promoting personal contact amongst the members, either independently or jointly with any other body or bodies
- (h) To promote among the members of the Federation, a spirit of fellow feeling and to develop mutual association by organizing meetings, cultural programmes and other activities conducive to the attainment of this objective.
- (i) To print and publish any circulars, periodicals, books, leaflets, and to prepare, print and publish and distribute such journals, books and other publications and procure articles, advertisements or other matter that may seem desirable in the interest of the Federation in general.
- (j) To collect statistics and statistical data on matters of interest of the Federation and its members.
- (k) To create such classes of members such as Ordinary, Associate, Corporate, Honorary, Patron or any other class of members as may be considered to promote the above objects.
